



# Sutton Compact Annual Event 2019

and community sector can support the review process and co-design the development of commissioning strategies and processes.

#### The Discussions:

Following the presentation there was a question and answer session with the following actions agreed:


- 1. The production of a paper that enables the Compact Principles to be used as a framework for scrutinising the development of the Outcome Based Reviews Commissioning Strategies and processes.
- 2. Review the Compact Membership List.
- 3. Schedule in Compact meeting bimonthly for 2019/20.
- 4. To review the knowledge base of Councillors in relation to the Compact and take necessary corrective action.

Participants then split into small groups to consider what the voluntary and community sector could offer in relation to:

- a) Co-design of new services.
- b) Living Well Independently Outcome Review.
- c) Place Based Commissioning.
- d) Service user engagement.

As well as considering the above areas during the event it was also agreed that task and finish groups would be established to enable focused discussion to take place on what the voluntary and community sector can offer in relation to:

- e) Monitoring the impact of the delivery of commissioning strategies.
- f) Learning Disability Pathways.
- g) Over 65's System Approach.
- h) Children with Disabilities.



#### Co-Design of New Services

- "Overlap" impacts on all the individual missions of what is needed so therefore look at outcomes.
- Barcelona 5 aspects/priorities we need to be cohesive in looking at what we can offer back, across all areas.
- LBS to recognise dynamism and what is already happening in (eg) Learning & Disability areas LBS to offer a detached oversight and the day-to-day, actual work being done in "real" life.
- More "thinking outside of the box" for using Direct Payments, rather than "commissioned" services (i.e. Nickel Support).
- Model; of LBS see/saw commissioning as a means of career structure to adhere to
- Qualitive results count quantitive.
- Charities/social enterprises all doing similar work measure those social values as outcomes.
- Co-design LBS "long-term" employees?? or delegate the chair/board to local voluntary and community sector with some high level and autonomy.

## How voluntary sector can assist "Living Well Independently"

- Make sure all aspects and services of the voluntary sector can be input into this
- Make sure groups of young people and young people with disabilities are represented.
- Communicating needs of young people from own experiences and providing information.
- Focus on all groups, ethnicities and cultures to make sure it is fully inclusive and not "one size fits all"!
- Provide data from projects and define statistics.
- Engagement with different representatives through the needs assessment process.
- As you meet part of need, outcome changes, so should be reviewed.
- Make sure contract and new services are outcomes rather than target lead.
- Provide a sense check. Is intended outcome achievable and does this hit need?
- What is "Living Well Independently"? Different perceptions of this.
- Feedback on successful and unsuccessful projects to make sure we learn from past experiences.
- More partnership working.


- An understanding of the wider systems and wider determinants of health.
- Practical ways to overcome barriers to "Living Well Independently" and stop social isolation.
- If people are not living well independently cost more in the long run, so early intervention essential. Interdependently and not in isolation.

#### Place Based Commissioning

- Community Action Sutton social action lead in St Helier and Wallington and other geographical areas? (short and long term).
- Development of Hill House as a community hub in St Helier.
- Support needs assessment in local areas.
- Community Assets Mapping.
- Social prescribing at PCN level.
- Sharing intelligence on need and gaps in service.
- Sutton High Street ?? £150,000 how can this be utilised?
- Trading Associations Rose Hill, Middleton Circle.
- Faith Groups in particular places.
