Action on climate change

By 2027 Sutton will be a sustainable, green borough, with everyone taking responsibility for their impact on the environment.

- Keep Sutton a great place to live, enhancing the natural environment by caring for landscapes and wildlife.

Review and continue to deliver the Environment Strategy and Climate Emergency Response Plan	Annual renewal of the Environment Strategy and Climate Emergency Response Plan to reflect latest climate priorities, funding opportunities and innovation. This will also include updating the Air Quality Action Plan.
Develop a Climate Financial Strategy	Develop a strategy to identify the funding needed to combat climate change, and seek to secure c. £1m per year of external funding.
Decarbonise Council buildings	Explore options to make Council buildings more energy efficient and climate friendly, and implement a programme of changes
Encourage businesses to decarbonise	Support 50 businesses to decarbonise through the Green Enterprise Partnership in Sutton town centre.
Use technology to tackle climate change	Continue to explore options to use the latest technology to support our climate ambitions. For example; reducing the Council's carbon footprint through the use of modern, highly efficient cloud data centres; continue the Internet of Things programme to provide data to inform and measure the impact of climate change activity.
Lobby government to deliver on their national commitments on the environment	Lobby government to deliver on their national commitments on the environment, including providing funding to local authorities to support decarbonisation at a local level.
Improve and encourage sustainable transport in the borough	Take action to encourage and enable people to make sustainable transport choices, including: delivering the Sutton Town Centre Public Realm Masterplan; delivering four new school streets by 2024; reviewing opportunities for 20mph areas and HGV bans; developing and delivering cycle parking, cycle hangars and cycle lanes and continuing to deliver a cycle training programme; continuing the e-bike trial until October 2023 and working towards delivering a permanent solution; encouraging the uptake of Freedom Passes; exploring the use of pool cars, scooters and e-bikes for Council staff; and exploring innovate sustainable transport solutions including demand responsive transport.

Produce a borough wide Electric Vehicle strategy	Review opportunities to increase the number of Electric Vehicle charging points in order to encourage the uptake of electric vehicles. Explore options to convert the Council's small vehicle fleet to electric vehicles. Require contractors to use electric vehicles where suitable.
Minimise waste and work towards a 'circular economy'	Work to achieve a 'circular economy' and minimise waste by: reviewing the Council's waste and recycling policies and strategies; reviewing the waste service offer and making a decision on future provision; focusing on key areas to improve recycling (including flats, and the street environment); and taking other measures to make it easier for residents to reduce waste, repurpose and repair items.
Continue to deliver the Library of Things	Continue to provide a 'Library of Things' to allow customers to borrow household items such as drills, sewing machines, carpet cleaners and ice cream makers, in order to encourage reuse of items and reduce waste.
Continue to deliver an education and environmental enforcement service	Continue to educate and enforce fly tipping, littering, dog fouling and other environmental crimes. Review existing model of delivery by the end of 2024.
Expand the Sutton Decentralised Energy Network (SDEN)	Establish the viability to deliver the Phase 2 heat network expansion plan to include Clarion Housing at The Lavenders and Sutton town centre. Explore the long-term future direction of the company.
Develop and deliver flood alleviation schemes	Deliver flood alleviation schemes in Worcester Park, Rosehill Park and Beddington (subject to funding). Continue to deliver the SUDS (Sustainable Urban Drainage Systems) programme in schools.
Roll out LED Street Lighting	Convert all street lights to LED across the borough over a 4 year programme, delivering significant financial savings and reducing carbon.
Monitor and advise on the restoration of Beddington Farmlands	Work with the Conservation & Access Management Committee and landowners to ensure that each habitat defined in the farmlands restoration management plan is restored in full by the end of 2023.
Continue to plant more trees and hedgerows across the borough	Work with residents and other stakeholders to identify spaces for tree and hedgerow planting and bid for external funding.
Work with schools to encourage awareness of the environment and climate change	Provide environmental education at Sutton Ecology Centre for 3500 school age children a year. Through the Sutton STEAMS Ahead (Cultural Impact Award) programme, allow every school child in Sutton to experience Science, Technology, Engineering, Arts and Maths (STEAM) for a day during 2023, with an emphasis on the environment and climate change.
Upgrade playgrounds, tennis courts and other parks facilities to encourage active	Support residents to be physically active by promoting use of parks, and maintaining a network of playspaces. Work with sports bodies and clubs to provide a range of sports and leisure activities. Focus on improving the accessibility of parks for children with disabilities.

Sustain and enhance parks and open spaces, and develop a new mini park (GreenSpaces project)	Support the development of new 'friends groups' for parks, and support groups to meet their ambitions for their local parks by producing parks management plans. Apply for Green Flags for key parks to verify what has been achieved. Deliver a community led project at the Limes Avenue Recreation Ground to increase green space where this is currently lacking.

Quality and affordable housing

By 2027, more people in Sutton will live in safe, high quality and affordable homes.

- Increase the amount of affordable homes in the borough by building new homes, regenerating Council estates, and exploring innovative ways to increase housing supply.
- Ensure that all Council housing is safe, sustainable and good quality.
- Work with partners to support people who are homeless or at risk of becoming homeless, intervening early before issues escalate.

Deliver new Council homes	Deliver 405 new, low carbon Council homes at various locations across the borough by 2028.
Continue investing to maintain and improve Council homes	Through Sutton Housing Partnership, deliver a 5 year programme of investment; ensure all Council housing meets the latest quality and safety standards.
Make Council homes more energy efficient	Retrofit 60 homes with the latest energy efficiency measures, decarbonise 75 Council homes via the Social Housing Decarbonisation Fund programme, and secure external funding for delivery of further decarbonisation schemes.
Work with residents and communities to regenerate Council estates	Complete delivery of the Beech Tree Place regeneration, progress regeneration of Elm Grove, complete an options appraisal for the regeneration of Benhill Estate and review the feasibility of regeneration for the remaining estates within the Estate Regeneration Programme.
Increase the number of affordable private rented homes in Sutton	Work with Sutton Living Limited to provide affordable private rented housing for Sutton residents.
Work with partners to prevent homelessness and support people who become homeless	Update the Homelessness Strategy by 2023, and deliver the strategy in line with agreed targets (to include taking steps to prevent people becoming homeless, supporting those who are homeless, and reducing the number of people living in temporary accommodation)
Support young families in temporary accommodation	Work with partners to provide a range of advice and support to families with preschool children who are living in emergency or temporary accommodation.
Review the Local Plan	Review the Local Plan by 2024 to improve quality and affordable housing in the borough, including a new policy on addressing the climate emergency.
Explore Council licensing for Houses in Multiple Occupation	Improve the standard of private rented sector accommodation by exploring the feasibility of an additional council licensing scheme for houses in multiple occupation.

- Continue to deliver major regeneration schemes including Sutton Town Centre Regeneration and the ground-breaking London Cancer Hub

Support residents and businesses impacted by the rising cost of living	Work with our partners to provide a range of advice and support to residents and businesses impacted by the rising cost of living, to protect the most vulnerable and support Sutton's economy to recover in the longer term.
Develop and deliver an economic growth programme	Deliver a Careers Hub to support high quality careers programmes for students; support unemployed and economically inactive Sutton residents into work; tackle skills gaps in priority sectors (for example, the 'green' sector), and help local businesses to access training and advice.
Develop and deliver a Digital Inclusion Strategy	Develop a Digital Inclusion Strategy to increase digital access, connectivity and skills. Increase digital access in Council libraries, and continue to offer free digital skills qualifications and access to devices (via Sutton College) to support learning and employability.
Offer targeted education and skills support to promote learning and increase employability	Working with a range of partners including Sutton College, continue to offer a range of targeted education and skills interventions. Strengthen links between local employers and higher education to promote skills development and business growth, including through the delivery of the 'BIG South London' business support programme.
Promote the Council as a great employer for local people	Promote Sutton Council as an employer of choice, working with schools and colleges to promote apprenticeships and careers in the Council and attract students studying for careers in hard to fill areas. Develop a specific offer for vulnerable young people to gain access to employment through the council. Maximise opportunities for them through our commissioned service providers and partners.
Continue to deliver the Sutton Town Centre regeneration programme	Work with partners and the local community to continue to regenerate Sutton Town Centre, including: delivering Throwley Yard project (a cultural venue); delivering 'Oru Sutton' (a mixed use scheme providing affordable office space, exhibition space, hospitality, wellness suite and intergenerational growing space); increasing the wider cultural and education offer; and revitalising the northern end of the High Street.

Develop and deliver a regeneration strategy for St Nicholas Centre and Civic Complex	Set out the business case and regeneration strategy for the St Nicholas Centre and the Civic Complex in line with the key priorities and objectives for Sutton Town Centre, and procure a preferred delivery partner.
Improve transport in Sutton Town Centre	Develop and agree an improved layout for the town centre gyratory with stakeholders which includes sustainable transport improvements for cycling, walking and buses. Delivery to be linked to key developments across the town centre as they come forward.
Improve the street scene environment in the town centre	Roll out further smart bin technology, develop plans for improving waste collections from flats and businesses, increase enforcement and education around fly tipping and continue to improve the 'public realm' in Sutton town centre and district centres through greening and sustainable transport improvements.
Work with partners to maintain town and district centres as a safe place to be	Continue multi-agency problem solving work to make Sutton's town and district centres safer, including: working with businesses to implement the counter-terrorism Protect Duty; implementing the Women's Night Safety Charter; continuing to commission targeted youth work through the MOPAC funded 'On the Street' project; and addressing street space issues relating to delivery drivers and the takeaway economy.
Continue to work with our partners to deliver the ground-breaking London Cancer Hub	Secure an investor/developer partner to deliver the major life science regeneration at the district in Belmont. This scheme proposes to deliver c.600,000 sqft / 55,000 sqm of new space, c.2,750 jobs, and c.£2.5m business rates (per year).
Improve sustainable transport access to London Cancer Hub	Develop sustainable transport solutions to improve accessibility of the London Cancer Hub for all.
Work with Sutton United Football club to increase local benefits	Work with Sutton United Football Club to ensure the economic benefits associated with an expanding club are felt locally bringing access to jobs, strengthening business supply chain opportunities, harnessing spend from fans, and encouraging more active lifestyles

Lobby government to ensure Sutton has the resources to deliver new policy priorities and legislation	Lobby government for clarity on requirements and adequate resources to deliver new policy and legislation, with a focus on: Adult Social Care reforms; new legislation relating to the Waste and Resources Strategy; changes to local authority responsibilities for building safety; funding for homelessness prevention; funding for resettlement of refugees and asylum seekers.
Continue to ensure good quality hospital provision in the borough	To continue work with NHS and community partners to ensure that there is good quality, accessible healthcare provision in the borough and protect services at St Helier Hospital.
Work closely with the police to maintain effective policing resource	Work closely with the police to ensure key crime and policing issues are prioritised locally, including: ensuring Sutton has the resource to deliver and embed the counter-terrorism Protect Duty; continuing to secure 'violence reduction' funding for Sutton from the Mayor's Office for Policing and Crime (MOPAC); continuing to work collaboratively with partners to secure other external funding.
Lobby for public transport improvements serving the borough	Lobby TfL and Government for funding and to prioritise public transport servicing the borough, focusing on: extending the Overground from Croydon to Sutton; electrification and expansion of buses servicing the borough; extending the Tram; expansion of the bus network; ensuring fairer access to transport funding streams.
Seek funding to deliver the Belmont Rail Frequency Improvement Scheme	Subject to the outcome of the Levelling Up Fund bid, build a rail siding at the south of Belmont Station to enable a change from the current 2 trains per hour to 4 trains per hour, make public realm improvements to Belmont Station and the immediate surroundings, and improve cycling and walking access in the area.

Lobby for improvements to flood management and prevention	Ensure Thames Water and the Environment Agency are fulfilling their obligations in relation to flood management and prevention, and lobby them for funding for flood management schemes.
Continue to lead The Libraries Consortium	Continue as the lead borough for The Libraries Consortium, which consists of 23 authorities working together. Continue to raise the profile of the consortium which is setting national standards for the way in which libraries can procure the best deals for books, e-books and other stock.
Deliver the Sutton STEAMs Ahead programme (GLA Cultural Impact Award)	Use funding secured from the Greater London Authority and National Heritage Lottery Fund to deliver a programme of cultural activity across all communities in Sutton, delivering a legacy and encouraging future investment in the borough.
